Detailed justification:

- The decision of the Flemish government (10/07/2020) officially establishes the renewed governance of Circular Flanders with Roadmap, Work Agendas, strategic levers and Steering Group. The first meeting of the Steering Group took place on December 1st 2020 as illustrated by the accompanying meeting report and powerpoint presentation, further detailing its composition and modus operandi.

- The text version of the Roadmap details its content as approved by the Steering Group on 06/12/2021. The final edition is now being prepared for publication with additional imagery. The official public launch is planned for April 2022.
