# **B.** Detailed justification:

<u>Target description</u>: (i) 37 professional sectors implement actions on non-discrimination (see Addenda non-discrimination and inclusion 2021-2022). (iii) The Flemish government assesses the implementation of each action on the basis of the individual predetermined commitments of each sector.

**Element (i)**; 37 professional sectors implement actions on non-discrimination (see Addenda non-discrimination and inclusion 2021-2022).

All sectors that have agreed to implement actions on non-discrimination can be found on the website of the Flemish government (Overzicht van sectorconvenants en addenda | Vlaanderen.be). The Addenda non-discrimination and inclusion 2021-2022 are part of the sector covenant that has been agreed upon by the sector and the Flemish government. For each sector, the Sector covenants and addenda non-discrimination 2021-2022 are provided in the documents BE-C[C51]-R[R-406]-T[141] sector covenants and BE-C[C51]-R[R-406]-T[141] Addenda. These documents include a description of the individual predetermined commitments of each sector, as well as the timing and other partners involved.

**Element (ii)**; The Flemish government assesses the implementation of each action on the basis of the individual predetermined commitments of each sector.

An assessment of the implementation of the addenda is made and is provided in document BE-C[C51]-R[R-406]-T[141] Policy report for each sector covenant. The evaluation is made thoroughly and indicates whether the sector has reached the specific goals they had set beforehand or not. When they have not reached the goals they had set, it is mentioned if they were motivated and made effort to reach their goals.
