

Summary document on Milestone 42 ‘Land purchases to reinforce biodiversity and/or mitigate climate change effects’

The Operational Arrangements document requires the following for the milestone reporting of milestone 42 in payment request 3 of the RRF:

Summary document duly justifying how the milestone (including the relevant elements of the milestone, as listed in the description of milestone and of the corresponding measure in the CID annex) was satisfactorily fulfilled. This document shall include as an annex the following documentary evidence: Listing and copies of title deeds of the purchases, with indication of the matching project site, the objective of the project (wetland restoration or other) and number of ha covered.

The description of milestone 42 “Land purchases finalised for wetland restoration projects (I) and for areas for nature-based solutions (G) (Approximately 1 000 hectares)” focuses on land purchases in two schemes of the Blue Deal.

G four areas for nature-based solutions

This scheme of the Blue Deal is based on four ‘Vlaggenschipprojecten’ for nature based solutions. In three of these projects, land purchases have been initiated and realized. In the fourth project (Complex Project in the Dunes) of the Blue Deal, several nature-based solutions are realized, but no land purchases and the realizations are not financed with the down-sized RRF budget of the Blue Deal.
