Taking into account the results of the Higher Education Advancement Fund, the vision note sets the scope for furrther developing a Flemish higher education portfolio that is future-proof and agile is addressed throughout the text. More specifically, the conclusions state that:

"This note shows that the results of actions within the Higher Education Advancement Fund have greatly exceeded expectations. The great merit of the Fund lies in the fact that the higher education institutions were given time, resources and space to experiment together and reflect deeply on their future-proofing. For instance, they evaluated their training portfolios, examined its relationship with lifelong learning and reached agreements on the use of micro-credentials.

The actions within the Higher Education Advancement Fund led to an accelerated and substantiated picture of what the higher education landscape can look like and the position higher education can hold within the context of lifelong learning. The willingness to cooperate between institutions was given a boost, the vision of the future was opened up and the path towards it cleared.

It goes without saying that the end point has not been reached and there is still a long way to go, but the criteria to be applied have been clarified and the results provide sufficient foundations to build on. In that sense, the Higher Education Advancement Fund is not an end point but rather an encouragement to continue with the same élan."
